HORNETS HIGH PERFORMANCE CENTRE MEMBERSHIP TERMS AND CONDITIONS

Welcome to the Hornets High Performance Centre, operated by Hills Basketball Association Ltd. ("HBA"). By registering for a membership, you agree to the following terms and conditions:

1. Membership Plans

- Your selected membership plan governs your access to the Centre's facilities and services.
- All memberships are subject to a minimum 3-month commitment period.
- After the initial period, the membership automatically renews monthly.
- A 30 days' written notice is required to cancel your membership.

2. Access & Use

- Access to the High Performance program is exclusively available to current Hornets
 Representative players. Any exceptions will be considered on a case-by-case basis at the
 discretion of the High Performance Manager.
- Athletes may be allocated to a specialised or alternate age group within the High Performance Centre to best support their individual development. Group placement is determined solely at the discretion of the High Performance Manager and is based on factors such as training needs, developmental priorities, and overall program structure.
- Access is restricted to active members with current payment status.
- Access may be temporarily restricted due to maintenance, safety, or events.

3. Behaviour & Compliance

- You must follow all rules, staff instructions, and safety signage at all times.
- Misconduct, unsafe behaviour, or failure to follow policies may result in suspension or termination of your membership.
- Respectful, responsible, and safe behaviour is expected of all members.
- Membership in the High Performance Centre is a privilege, not a requirement, for Hornets Representative players. Membership may be suspended or revoked at any time due to poor behaviour, lack of work ethic, or failure to uphold program standards.

4. Fees & Payment

- Fees are billed weekly in advance through your nominated payment method.
- Late or failed payments may result in access suspension and/or administration fees.
- Access will be denied if payments are unpaid.

5. Cancellation & or Pausing Membership

• You may cancel your membership after the 3-month commitment with 30 days' written notice (email hpc@hillshornets.com.au).

- Cancellations are not allowed during the commitment period unless due to medical issues (certificate required) or relocation (proof required).
- Membership pause for medical or travel reasons is available for 2 to 8 weeks per year with at least 7 days' written notice (email hpc@hillshornets.com.au).

6. Health & Safety

- You confirm that you (or the attendee) are in good health and capable of participating in physical activities.
- You are responsible for managing your own limits and for disclosing any relevant medical conditions.
- You are responsible for using equipment safely, appropriately and as per instructions.

7. Clothing & Attire

- Athletes must wear the required High Performance uniform at all times. This includes a
 Hornets reversible singlet or HPC reversible singlet, and black shorts, black pants
 (tracksuit or tights), or Hornets shorts.
- Enclosed sports shoes are required—bare feet, sandals, or thongs are not allowed.
- HBA may refuse access to any member not wearing the correct uniform.

8. Insurance

- All registered participants are covered under Basketball NSW's Player Insurance when participating in approved High Performance sessions.
- This insurance covers injury during scheduled sessions only and is subject to the terms set by Basketball NSW.
- It is the member's responsibility to ensure they are registered and to submit claims directly to Basketball NSW if required.

9. Shutdown Period

- The High Performance Centre may close for scheduled shutdown periods throughout the year (e.g., Christmas/New Year, major venue works).
- Members will be notified in advance of any shutdown dates.
- These periods do not affect your minimum commitment but may be taken into account for extensions or pause requests, at HBA's discretion.
- Members do not pay subscription during HBA Shutdown Periods, this does not include public holidays.

10. Liability Waiver

- To the extent permitted by law, HBA is not liable for personal injury, loss, or damage occurring on premises unless caused by proven negligence.
- Members assume the risk associated with physical training and equipment use.
